Apr 2019	472,200,000	Explosion and fire loss to a construction project of refinery and petrochemical integrated plant in Pengerang, Johor.
Apr 2019	118,847,637	Fire loss at a silicone synthesis plant in Pulau Indah Klang, Selangor.
Jun 2019	83,000,000	Breakage of a third stage rotating blade at a power station in Klang, Selangor
Jul 2019	61,709,000	Fire loss at a biomass plant in Segamat, Johor
Feb 2019	57,000,000	Fire loss at a laminated boards and engineered hardwood flooring boards plant in Gopeng, Perak.
Sep 2019	40,100,000	Fire loss at a beach resort
Aug 2019	28,026,430	Fire loss at a veneer and plywood factory in Miri, Sarawak.
Mar 2019	24,585,000	Fire loss at a steel products manufacturer in Prai, Penang
Jul 2019	12,444,340	Fire loss at a warehouse & manufacturing plant of agriculture chemical in Pulau Indah, Selangor.
Oct 2019	11,240,000	Fire loss at a manufacturing plant of polyester thread in Teluk Panglima Garang, Selangor.

## MAJOR LOSSES IN MALAYSIA - MOTOR

Date of Loss	Market Loss Amount	Description of Loss
Oct 2015	7,760,806	Insured driver alleged a vehicle from opposite has used high light and caused his eye sight to be blurred and unable to see the traffic in front and suddenly an impact between his vehicle and a motor car. Nursing case form the bulk of the claim.
Dec 2015	5,639,099	The third party pedestrian sustained severe injury, currently bed ridden and still undergoing treatment. Nursing case form the bulk of the claim.
May 2017	5,321,777	Insured vehicle collided with a motorcycle. The third party rider is permanently disabled and pillion were severy injured.
Jan 2016	4,581,602	Insured motorcycle collided with a motorcycle which caused both of them fell onto the road. The insured had injured and lost consciousness while the 3rd party has sustained severe head injury. Now, the 3rd party is totally and permanently disabled for life and completely dependent on assistance for all daily activities.
Oct 2015	4,649,608	Insured motor lorry collided into third party tourist bus. There were 21 passengers in the insured motor bus and due to the accident 4 succumbed to their injuries while 17 had sustained injuries.
Aug 2015	4,600,939	Insured vehicle and 3rd party super bike. The 3rd party sustained multiple injuries and now still on wheel chair.
Aug 2015	4,346,207	As the Insured reversed out onto the main road, she heard a loud bang coming from the left side of her vehicle and the third party was lying unconscious on the road. The third party sustained head injury causing him now paralyzed, forgetful and required assistance for activities of daily living.
Jan 2017	4,278,275	Insured vehicle collided into a motorcycle. The rider and the pillion rider of third party vehicle injured severely.
Aug 2018	3,054,326	Insured vehicle collided into a motorcycle. The third party rider's right leg amputated and right hand crushed (metal inserted) due to the accident.
Jul 2017	2,583,106	Insured vehicle collided with a motorcar. The third party rider suffered severe traumatic brain injury with bilateral lung contusion, remains bedridden and total independence for all activities of basis daily living.
